August 24, 1926 - April 8, 2009

Major Travis E. Davenport, USMC (Ret.), 82, was born in San Antonio, Texas to Travis and Eleanor Davenport on August 24, 1926. He died on April 4, 2009. Major Davenport was raised in Houston, Texas and graduated from Reagan High School. Upon graduation he enlisted in the United States Marines Corps in 1944, and served during World War II in the Pacific Theatre, Korea and Vietnam. He served a total of twenty-three years in the Marine Corps retiring as a Major. After his retirement, Travis was self-employed for the next twenty years as vice president of Cook Equipment Co. in Houston, Texas. Major Davenport is survived by his wife of sixty years, Alice Frances Cook Davenport; his sister Doris Thomson; his daughter Susan Cragg and husband Peter of the Woodlands, TX, his daughter Joan Davenport of Houston, TX, his daughter June Davis and husband Ken of Huntsville, TX; grandchildren Christopher Davis and wife Cathy, Emily Heinemann and husband Kyle, Fran Levantino and her husband Justin, April George and husband Nathan, Travis Cragg and Ellen Davis; great-grandchildren Riley Davis, Hannah Heinemann, Jacob Levantino and Wesley Heinemann, and numerous nieces and nephews.
